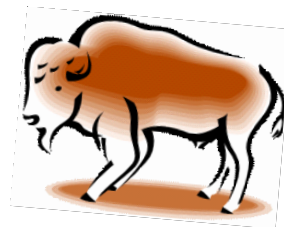

President's Corner



Kathy Brenniman, Lori Driscoll, Doris Schertz, Loretta Caputo and I recently attended the 2009 **AAUW National Convention** held June 26th to 28th in St. Louis.

Lilly Ledbetter, the face of pay equity, was the keynote speaker at the opening event on Friday afternoon. It was a powerful experience to see and hear this woman whose grievance with Goodyear Tire went all the way to the Supreme Court, was ruled against, and yet was then turned into a bill and passed by the House and Senate. In January 2009, the Lilly Ledbetter Fair Pay Act was the first bill that President Obama signed into law.

On Saturday morning, our speaker was **Rep. Rosa DeLauro** (D-CT), who is currently serving her tenth term in Congress and sits on the influential House Appropriations and Budget Committee. Rep. DeLauro has worked tirelessly to pass the Fair Pay Act in the House after years of effort and now continues with renewed effort to persuade Senators to pass this bill as well. We were tremendously energized to hear this public servant who is so devoted to women's causes.

At the Convention Banquet on Saturday evening, the speaker was **Rep. Jackie Speier** (D-CA), another dynamic woman who is a champion for women and girls. Also during the banquet, Illinois was honored as one of the top ten states for contributions to LAF, EF, Eleanor Roosevelt Fund, Leadership and Training Institute, and also for states that are advocates for laws and policies that are fair to women.

While it is difficult to impart the excitement and enthusiasm engendered by these speakers and celebrations, they were the "icing on the cake" between work segments as we debated and eventually came to consensus on Convention Rules, By-Laws, and the Public Policy Program. In each category, convention delegates requested additions, deletions and explanations on various items. Many motions were made and votes taken before agreements were reached.

Foremost among the difficult decisions was the **subject of open membership**. After much heated debate, the subject of open membership was tabled until a future time. The subject of "**one member one vote**" **passed easily** and the idea of open membership will be brought up again when all members are able to decide for themselves.

All in all, the Convention was exhilarating, informative, entertaining and exhausting. A 2011 Convention in D.C. was announced. Save the date!

Return-to-Learning Graduate:

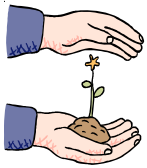

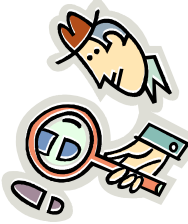
